- All admissions materials must be received in our office and your entrance exam completed no later than June 30. EARLY ADMISSIONS are from January 1 March <u>31</u>. Late application will require prior approval.

Once a <u>complete application packet</u> is received in our Administrative Offices you will be contacted by telephone and may receive a brief screening prior to being scheduled for the Entrance Exam & Interview appointment.

Acceptance notifications will be provided by email letter no later than **July 10** if your application packet was submitted on-time.


